Privacy Statement

University of California California Institute for Energy and Environment

Policy

The University of California is committed to protecting the privacy and accuracy of your personally identifiable information to the extent possible, subject to provisions of state and federal law. Other than as required by laws that guarantee public access to certain types of information, or in response to subpoenas or other legal instruments that authorize disclosure, personally identifiable information is not disclosed without your consent.

Information Collection and Use

Categories of personally identifiable information collected by California Institute for Energy and Environment (CIEE) include: referring IP, IP geographic location, submitted content(*), feedback information(*). The personally identifiable information requested by us is for the purposes designing a better user experience. Fields marked with an "*" are required to verify submitted content and provide a timely response to user requests. Article IX, Section 9 of the California Constitution grants authority to the University of California to maintain this information.

In order to keep you informed of such activities as campus programs, symposia and/or special events, we may use personal information collected from UCB Web sites for the purpose of future communication back to online enrollees. Such email notification will be conducted in conformance with University of California and campus policies implementing anti-spam laws (<http://www.ucop.edu/irc/policy/antispam.pdf>).

Additionally, the Web server SiteGround.com collects, at least temporarily, the following information: [Internet Protocol (IP) address of computer being used; Web pages requested; referring Web page; browser used; date and time]. This information is collected to monitor your navigation of our Web pages. We may use browser-IP-address information and anonymous-browser history to report information about site accesses and for profiling purposes. This information is generally used to improve Web presentation and utilization. We also may use IP address information for troubleshooting purposes.

CIEE online activity may use "cookies" in order to deliver Web content specific to individual's Web navigation interests. Personally identifiable information is not stored within cookies.

Disclosure of Collected Information

CIEE will not disclose or share, without your consent, personally identifiable information, except for certain explicit circumstances in which disclosure may be required by law. Disclosure may include information such IP address, referring IP address, geographic location, and any information provided

when submitting feedback. Your personally identifiable information will not be distributed or sold to third-party organizations.
