

#### **Request for Qualifications** Interconnection Dispute Resolution Panel: Technical Advisor

The California Institute for Energy and Environment (CIEE) and the Center for Law, Energy & Environment (CLEE) at UC Berkeley Law are looking to identify and recommend for California Public Utilities Comission selection a group of Technical Advisors to conduct research and/or provide expertise in support of the expedited dispute resolution technical panel and its members as needed.

Electric Rule 21 is a tariff that describes the interconnection, operating and metering requirements for generation facilities to be connected to a utility's distribution system. The tariff provides customers wishing to install generating or storage facilities on their premises with access to the electric grid while protecting the safety and reliability of the distribution and transmission systems at the local and system levels.

In recent years, growth in the number of requests to interconnect solar photovoltaic (PV) systems to the utility grid has raised new issues and challenges for PV installers, utilities, and ultimately the PV customers who absorb the costs of interconnection challenges. The increased volume of interconnection requests and the evolving market for distributed energy resources (DERs) has led California to revisit and revise Rule 21 interconnection requirements and have caused utilities to streamline and automate interconnection processes.

Assembly Bill (AB) 2861 (Stats. 2016, Ch. 672), signed into law in September 2016, authorizes the California Public Utilities Commission (CPUC) to establish an expedited dispute resolution (EDR) process that will issue binding determinations to electric distribution grid interconnection disputes based on the recommendations of a technical panel within 60 days of the Commission receiving the Application regarding a particular dispute.

The deadline to apply is June 15th, and the full RFQ, including requirements for the positition and instruction on how to apply, can be found on our website.

#### CITRIS COVID-19 Seed Funding

CITRIS and the Banatao Institute has launched a COVID-19 response with 25 awards for innovative technologies, potential "game-changers" for the diagnostics, therapeutics, and mitigation of the pandemic.

Before the application deadline, an anonymous donor expanded potential funding exponentially with a \$1.6 million matching challenge, allowing for more projects to be awarded at an average of \$50,000 for each grant. Among the 97 proposals received, 25 projects were chosen, including next-gen face masks, new algorithms for contact tracing and advance prediction, a genome browser to integrate molecular-level genetic information to accelerate research, and a point-of-care rapid-testing device the size of a credit card.

#### BECC Webinar: "Transformational Communications: Increasing Government Ambition in Public Engagement on Climate Change"

BECC's next free webinar will be held on on Wednesday, June 24th, from 11:00 AM - 12:00 PM PDT!

Governments have failed to effectively engage people on the issue of climate change, even 30 years after committing in the Framework Convention to inform and educate their citizens about this critical issue. Today, people are still disturbingly ill-informed about what is causing climate change, how urgent it is, and how it will impact their lives. So, how do we assert people's legal (and moral) right to know, and how can we transform our approach to engagement in order to overcome polarization and build a broad-based public mandate to support action? George Marshall, the founder of Climate Outreach, a non-profit based in Oxford, UK that is Europe's leading specialist in climate change communication, will make the case that public engagement is essential for achieving our climate targets and will discuss a major new international initiative to transform government commitments to public engagement.
